## **YOUR DAY BY DAY ITINERARY**

### **TUE, JUL 7 – LOS ANGELES/ACROSS THE ATLANTIC**

Depart Los Angeles today and connect with your overnight transatlantic jet flight.

### **WED, JUL 8 – ARRIVE BERLIN**

Arrive in historic Berlin where you will be met and escorted to your waiting motorcoach for the transfer to your hotel. (D)

### **THU, JUL 9 – BERLIN**

This morning visit reunited Berlin. In the former West, see Charlottenburg Castle, Kaiser Wilhelm Memorial Church, the famous Kurfurstendamm, Bellevue Castle, the Cultural Forum and the Reichstag Building. In former Eastern Berlin, see the Brandenburg Gate at the end of beautiful Unter Den Linden Boulevard, Gendarmen Markt, the Berlin Cathedral, Alexanderplatz, the Nikolai Quarter, and the remains of the Berlin Wall. The afternoon is free to explore Berlin on your own. (B)

### **FRI, JUL 10 – BERLIN/DRESDEN/PRAGUE**

This morning depart Berlin and head southeast to Dresden, capital city of the Free State of Saxony and renowned center for fine art and world-class porcelain. Dating from the 12th Century, Dresden is a stunningly beautiful city, sitting majestically astride the stately waters of the River Elbe. Though destroyed by the allied bombings of 1945, many of the fine Renaissance, Baroque and Classical buildings have been wonderfully restored in recent years, returning

the city to its stunning former glory as “*The Jewel Box*” of Europe. On your orientation tour of the city, see the Semper Opera House, Zwinger Palace, and The Church of Our Lady (Frauenkirche), one of Germany’s most amazing post-WW2 reconstructions. Afterwards, cross the Czech border driving through the verdant farmlands of Bohemia to historic, 1,000-year-old Prague on the Vltava River. (B,D)

**SAT, JUL 11 – PRAGUE**

This morning experience the 1000 years of Prague’s history with a visit to Hradcany Castle, the seat of power for several Czech princes and kings. Proceed to the Gothic St. Vitus Cathedral, the Romanesque Basilica of St. George and Mala Strana (Lesser Town), whose winding streets are lined with small taverns and old houses. Continue to Old Town to see the ancient Town Hall with its animated astronomical clock. The afternoon is at leisure. (B)

**SUN, JUL 12 – PRAGUE/ČESKÝ KRUMLOV/VIENNA**

Bidding farewell to the Czech Republic’s enchanting capital, travel through the south Bohemian countryside, passing picturesque villages and ponds, to Český Krumlov. Known as ‘*the Pearl of the Renaissance*’, the State Castle of Český Krumlov is one of the most important historic sites in Central Europe. Following a panoramic tour, continue across the border into Austria proceeding to Vienna, once the center of the mighty Hapsburg Empire. A unique European metropolis, the city itself contains more than a million inhabitants and is set in beautiful surroundings. (B,D)

**MON, JUL 13 – VIENNA**

This morning enjoy a sightseeing tour of Vienna beginning with a drive around the Ringstrasse, one of the most magnificent boulevards in the world. It encloses the Inner City and such noble edifices as the Votive Church, built in 1856, the University, the City Hall and the Opera House. Continue to Schönbrunn Palace with its glorious French Park. The Palace has 1400 rooms and halls, a small zoo and a fine museum of state coaches. Your afternoon is at leisure for shopping or exploring on your own. (B)

**TUE, JUL 14 – VIENNA/SALZBURG**

Enjoy views of the scenic Austrian countryside on your drive this morning to the “Sound of Music” city of Salzburg, one of the world’s most beautiful places. Upon arrival take an orientation tour of Salzburg which will take you past the most beautiful sights of the city. Drive via the Schloss Mirabell and the Kongresshaus. Continue via Schwarzstrasse and the Protestant Church to the Mozarteum and then past the Marionetten Theatre, Landes Theatre, Marktplatz, and Rathaus to view where Mozart was born. (B,D)

**WED, JUL 15 – SALZBURG/OBERAMMERGAU**

Today cross the border into Germany and ascend the Bavarian Alps for a panoramic view of Mad King Ludwig’s fairy-tale Neuschwanstein Castle, one of the most photographed palaces in the world and the model for the castles at the Walt Disney theme parks. Next visit the unusual, oval rococo Wies Church designed in the late 1740s. On to Oberammergau, site of the world- famous Passion Play. (B,D)

**THU, JUL 16 – THE PASSION PLAY OF OBERAMMERGAU**

The highlight of your trip! In keeping with their 387-year old promise, the villagers of Oberammergau present their Passion Play depicting the last week of the life of Christ. The play’s presentation can be traced to 1633 when the Black Plague swept Europe. The people of Oberammergau took a solemn oath: if God spared them, they would present a day-long play depicting the last week in the life of Christ. To this day they have kept their promise and every ten years the citizens of Oberammergau perform their passion play with the same love and devotion they have shown for over 380 years. Today the play takes place on an open-air stage with a covered auditorium seating 4,700, against a beautiful backdrop of towering Alpine mountains. (B,D)

**FRI, JUL 17 – OBERAMMERGAU/MUNICH AREA**

This morning, depart Oberammergau for Munich, the capital of Bavaria. Your orientation tour of Munich takes you via Karolinenplatz and past the 1000-foot-high Television Tower to Nymphenburg, the former Royal Residence. Drive on to Odeon Square with the beautiful Theatiner Church and the Hall of Generals. The afternoon is at leisure. Overnight in the Munich area. (B,D)

**SAT, JUL 18 – MUNICH/LOS ANGELES**

Your journey is over as you transfer to Munich Airport and board your return flight back to Los Angeles, arriving the same day. (B)

# GENERAL CONDITIONS

## RESERVATIONS, DEPOSITS AND FINAL PAYMENT:

Reservations may be secured upon payment of an initial deposit of \$200 per person. No reservation is considered firm until your deposit has been received. Your initial deposit payment shall be deemed to be an acceptance of all the terms of our General Conditions. Tickets to the Passion Play are limited and available on a first come, first served basis. A second deposit of \$600 is due by December 1, 2018 (total deposit required by 12/1/18 is \$800). An additional \$1200 deposit is due by July 31, 2019 (total deposit required by 7/31/19 is \$2000). The balance of payment is due at Nawas 135 days prior to departure.

Nawas accepts Visa, Mastercard and American Express for balance/final payments only. Credit cards are not accepted for deposits. The price of the tour already includes a built-in discount of 3% for payments made by cash or check. There is no discount on credit card sales. Credit cards will only be accepted prior to the final payment due date. Credit card charges cannot be accepted over the telephone. Tour members who choose to use a credit card for their final payment should contact Nawas before the final payment is due for further information.

**TRAVEL DOCUMENTS: A U.S.A. passport valid for at least 6 months after your return date of the trip is required to travel.** It is the sole responsibility of the traveler to check their passport's expiration date. Non-U.S.A. citizens may require visas in addition to a valid passport. It is the sole responsibility of non-U.S.A. citizens (including green card holders) to ensure they have the required visas/travel documents for each country to be visited on their tour and for re-entry into the U.S.A. Visa fees (if any) are not included in the tour price.

## THE TOUR PRICE INCLUDES:

**AIR TRANSPORTATION:** By any IATA/ARC air carrier or other scheduled jet carrier in standard economy class. Flights and air routings are at the discretion of air carriers and are subject to change without notice. Air arrangements are based on non-refundable bulk group airfares and cannot be upgraded. Cancellations made after air tickets have been issued are subject to full cancellation penalties as imposed by the airlines. Per TSA regulations, airline tickets must bear your first, middle, and last name as it appears on your passport and passengers are responsible to bear any name-change fees should they not provide Nawas with accurate passport information.

**AIRLINE SEATING:** Nawas contracts non-refundable bulk group airfares in standard economy class. **Airlines no longer provide seat assignments for groups and Nawas does not guarantee specific seat assignments.** Seat assignments for groups are made at the discretion of the airline and are typically allocated by automated airline computer systems in alphabetical order. Seat assignments will not be advised until check in at the airport. Nawas cannot request and does not guarantee specific seat assignments.

**TAXES/SURCHARGES:** U.S. departure taxes, overseas airport taxes, overseas local government taxes, security fees and airline imposed international surcharges are included as of November 7, 2017 (taxes/surcharges current estimate is \$450 per person). Future price increases may be applied due to additional costs as imposed by a supplier or governments.

**SURFACE TRANSPORTATION:** By deluxe motorcoach.

**HOTEL ACCOMMODATIONS:** Except in Oberammergau, accommodations are at first class and select hotels based on two persons sharing a twin bedded room with private bath. For the Passion Play, accommodations will be in hotels and guest houses in and around the village of Oberammergau, Nawas cannot guarantee roommates. A person taking a single room (subject to availability) must pay a supplement of \$900. Single rooms are limited and may be small. Single rooms are not available in Oberammergau.

**MEALS:** Breakfast daily and 7 dinners are included.

**SIGHTSEEING:** As specified in the itinerary using motorcoach transportation or other conveyances as required. Entrance fees and the services of local English-speaking guides or tour managers are included.

**TRANSFERS:** Assistance and transfers from airports to hotels and vice versa in private motorcoach.

**PORTERAGE:** Porterage at hotels (where available) of one normal size suitcase (maximum weight 50 lbs.) is included in the tour price.

**HOTEL SERVICES CHARGES/TAXES:** Service charges and taxes normally included in bills, VAT and government taxes on hotel bills in effect on November 7, 2017 (excluding hotel tourist taxes), taxes on sightseeing and excursion trips are included in the tour price. Future price increases may be applied due to additional costs as imposed by a supplier or governments. Recovering VAT taxes is the sole responsibility of the passenger/purchaser.

**FLIGHT INSURANCE:** Automatic one hundred thousand dollars flight insurance policy for each Nawas-ticketed passenger, subject to policy terms and limitations.

**LAND ONLY/DEVIATIONS:** Passengers wishing to do their own air arrangements or wishing to deviate from the group itinerary must advise Nawas in writing no later than 180 days prior to departure. For air deviations, a \$100 non-refundable fee per person will be charged on all deviations in addition to any extra airfare that may be incurred. Air deviations are subject to availability and restrictions as imposed by the airlines.

**BAGGAGE:** Airlines may now charge baggage fees for checked luggage on international/domestic flights based on the policy of each carrier. The maximum number of pieces of luggage, the weight allowance and baggage dimensions may also vary by airline from the U.S.A. to overseas/domestic destinations and beyond. Many carriers require that checked luggage in economy class not exceed 50 lbs. with a combined length/width/height of 62 inches. Regulations vary for business/first class passengers. Carry-on bags only cannot have wheels and must fit in overhead bins or under your seat. Nawas Travel accepts no responsibility for loss or damage to the tour members' baggage or personal belongings at any time. Baggage insurance is recommended and is available upon written request.

**TRAVELERS REQUIRING SPECIAL ASSISTANCE:** Disabled travelers requiring special attention or care must advise NAWAS in writing at the time of reservation. Written cancellations received by Nawas Travel between December 2, 2018 and March 1, 2019, are subject to a \$600 per person cancellation fee. Written cancellations received by Nawas Travel between March 2, 2019 and August 1, 2019, are subject to an \$800 per person cancellation fee. Written cancellations received by Nawas Travel from August 2, 2019 up until 135 days prior to departure, are subject to a \$1800 per person cancellation fee. Credit cards will only be accepted prior to the final payment due date. Credit card charges cannot be accepted over the telephone. Tour members who choose to use a credit card for their final payment should contact Nawas before the final payment is due for further information.

**TRAVEL DOCUMENTS: A U.S.A. passport valid for at least 6 months after your return date of the trip is required to travel.** It is the sole responsibility of the traveler to check their passport's expiration date. Non-U.S.A. citizens may require visas in addition to a valid passport. It is the sole responsibility of non-U.S.A. citizens (including green card holders) to ensure they have the required visas/travel documents for each country to be visited on their tour and for re-entry into the U.S.A. Visa fees (if any) are not included in the tour price.

## THE TOUR PRICE INCLUDES:

**AIR TRANSPORTATION:** By any IATA/ARC air carrier or other scheduled jet carrier in standard economy class. Flights and air routings are at the discretion of air carriers and are subject to change without notice. Air arrangements are based on non-refundable bulk group airfares and cannot be upgraded. Cancellations made after air tickets have been issued are subject to full cancellation penalties as imposed by the airlines. Per TSA regulations, airline tickets must bear your first, middle, and last name as it appears on your passport and passengers are responsible to bear any name-change fees should they not provide Nawas with accurate passport information.

**AIRLINE SEATING:** Nawas contracts non-refundable bulk group airfares in standard economy class. **Airlines no longer provide seat assignments for groups and Nawas does not guarantee specific seat assignments.** Seat assignments for groups are made at the discretion of the airline and are typically allocated by automated airline computer systems in alphabetical order. Seat assignments will not be advised until check in at the airport. Nawas cannot request and does not guarantee specific seat assignments.

**TAXES/SURCHARGES:** U.S. departure taxes, overseas airport taxes, overseas local government taxes, security fees and airline imposed international surcharges are included as of November 7, 2017 (taxes/surcharges current estimate is \$450 per person). Future price increases may be applied due to additional costs as imposed by a supplier or governments.

**SURFACE TRANSPORTATION:** By deluxe motorcoach.

**HOTEL ACCOMMODATIONS:** Except in Oberammergau, accommodations are at first class and select hotels based on two persons sharing a twin bedded room with private bath. For the Passion Play, accommodations will be in hotels and guest houses in and around the village of Oberammergau, Nawas cannot guarantee roommates. A person taking a single room (subject to availability) must pay a supplement of \$900. Single rooms are limited and may be small. Single rooms are not available in Oberammergau.

**MEALS:** Breakfast daily and 7 dinners are included.

**SIGHTSEEING:** As specified in the itinerary using motorcoach transportation or other conveyances as required. Entrance fees and the services of local English-speaking guides or tour managers are included.

**TRANSFERS:** Assistance and transfers from airports to hotels and vice versa in private motorcoach.

**PORTERAGE:** Porterage at hotels (where available) of one normal size suitcase (maximum weight 50 lbs.) is included in the tour price.

**HOTEL SERVICES CHARGES/TAXES:** Service charges and taxes normally included in bills, VAT and government taxes on hotel bills in effect on November 7, 2017 (excluding hotel tourist taxes), taxes on sightseeing and excursion trips are included in the tour price. Carry-on bags only cannot have wheels and must fit in overhead bins or under your seat. Nawas Travel accepts no responsibility for loss or damage to the tour members' baggage or personal belongings at any time. Baggage insurance is recommended and is available upon written request.

**TRAVELERS REQUIRING SPECIAL ASSISTANCE:** Disabled travelers requiring special attention or care must advise NAWAS in writing at the time of reservation.
